
Reference advertisement bearing No. 5581 dated 24.10.2016 appeared in the leading newspapers on 26.10.2016/ 27.10.2016 as well as on the GMCH website www.gmch.gov.in.

The Written Test of the candidates who have applied Online for the post of Hostel Nurse, Optometrist/Refractionist, Technical Person and Vocational Instructor was held on 11.08.2017 (Friday) in Examination Hall , 6th Floor, Block – E , GMCH-32. After evaluation by the committee, the provisional result/marks obtained by the candidates in written test for each category of the posts have already been uploaded on the official website. The candidates who have obtained 50% marks (45% in case of PH category and 40% in case of SC candidates) are considered as qualified the written test as per criteria published in the advertisement. However, their candidature in the applied category, is subject to fulfilling the terms and conditions given in the advertisement especially with regard to age, qualification and experience prescribed for the respective post..Out of the qualified candidates, the candidature in the ratio of 5:1 (Five candidate against one post)is to be considered and final selection shall be made on merit strictly as per criteria published in the advertisement. 1. The candidates who have applied under OBC Category and further shortlisted after the written test may get ready the fresh OBC Certificate issued within one year by the Tehsildar/Executive Magistrate in the prescribed format and should have the clause of Non-creamy layer which is required at the time of submission hardcopy of application. The OBC certificate more than one year old will not be considered and the candidature will be considered in General Category, if otherwise eligible, for the same without any intimation as recruitment will be done in the time bound manner.
2. The candidates of other categories i.e. General, SC, PH, Ex-servicemen etc. who will be shortlisted may also get ready the certificates strictly as per advertisement, which are required at the time submission of hardcopy as no opportunity will be given to any candidate for submission of any certificate later on as recruitment will be done in the time bound manner.
